THE DIRECTOR

HAVING REGARD TO the EACEA's notice at the European Commission regarding the assignment of the Erasmus Charter for Higher Education n. 241221-LA-1-2014-1-IT-E4AKA1-ECHE to the "Stanislao Giacomantonio" Music Conservatory, through which the Institute is validated to implement all the activities provided for in the new Erasmus+ programme;

CONSIDERING that the national co-financing of the EU "ERASMUS+" programme according Law N° 183/1987 for the academic year 2014/2015 also allows the AFAM institutions to develop a new project endorsing both incoming and outgoing student mobility for studies or internships;

HAVING REGARD TO the note of the coordinator of International Relations which proposed the allotment of a contribution to students coming from other European HEIs with which the Conservatory of Cosenza has a bilateral agreement;

HAVING REGARD TO the Board of Director's resolution adopted at the third sitting of 02.2017 which assigned the project in question a budget of €12.000,00 from national Law 183/1987 assigned to the Consenza Conservatory for the 2014/2015 academic year;

Considering it necessary to provide

DECREES

the proposal to show interest for the assignment of an economic contribution to students registered at the European HEI in the EU ERASMUS+ programme, with which the Conservatory of Cosenza has established agreements of mobility for students who intend to spend a period of time studying in the Cosenza Conservatory during the 2017/2018 academic year.

ART. 1 – REQUIREMENTS FOR PARTECIPATION AND INCOMPATIBILITY

Application to participate in the assignment of the contribution may be made by students registered with the European HEI in the ERASMUS+, programme, who have received the right to mobility financed by their institute at the Cosenza Conservatory for not less than six months (180 days) and who are:

- registered for the following year for a Bachelor's course (ISCED 6 First Cycle/Bachelor's or equivalent);
- registered for a Master's course (ISCED 7 Second Cycle/Master's or equivalent);

and who:





- 4. are of age;
- 5. have a sufficient knowledge of English or Italian;
- 6. are citizens of a EU state or of another state that is part of the ERASMUS programme;

ART.2 PRESENTATION OF THE CANDIDATURE AND SELECTION

The forms (as below) for the candidature and the attachments must arrive, duly signed, at the Ufficio Protocollo of the Conservatorio "S. Giacomantonio" in Cosenza by 12.00 am on 31st May 2017.

The application can also be sent via certified e-mail or by registered post with a receipt of reception. If the application is sent by registered post with a receipt of reception, the candidate must also send a copy of the application via fax or e-mail (erasmus@conservatoriodicosenza.it) by 31st May 2017.

- 6) Curriculum vitae (in Italian and in English);
- 7) Transcript of records of the institute in which the candidate is registered;

8) Recording of a performance (CD or DVD) - lasting 15 minutes with at least two contrasting pieces – or compositions by the candidate (composition and electronic music students);² who should also attach the scores

Applications received after the date stated in the first paragraph will be evaluated and eventually be granted contributions if they are still available.

ART. 3 - CLASSIFICATION

The applications received, complete with all the requested attachments, will be examined by a commission consisting of the director or his delegate, the delegate for international relations and an academic who will assign a maximum of 40 marks, based on the following criteria:

Max 15 marks for the curriculum studiorum;

The average of the marks deduced from the Transcript of Records will be related to thirtieths and the score will be allocated as per the following table:

- Max 15 marks will be assigned for the performances sent (see. point 4. Art. 2);
- Max 10 will be assigned by the commission for the Student's CV;

The scholarships will be assigned as long as there are funds available for the students in the rankings.

In the case of equal marks, the younger candidate will get preference.

The publication of the results of the ranking on the site will be the effective notification to the winning candidates.

Complaints against the provisional ranking can be presented up to five days from its publication. The definitive raking will be published within 10 days of the publication of the provisional ranking.

ART. 4 - FINANCIAL CONTRIBUTION FOR MOBILITY

The contribution is assigned to students who place well in the classification as referred to in Art 3 and who commit to spending not less than 180 to their studies at the Cosenza Conservatory. The sum is € 500,00 per month and will be paid 5 days before the end of the month subject to the presentation of the declaration signed by the coordinator of international relations. This contribution is an incentive to promote international mobility, in addition to the regular contribution paid by the candidate's institute under the ERASMUS+ programme. It is, therefore, not to cover all expenses but is a contribution to the cost of living in Cosenza.

The duration of the scholarship is six months. The contribution will be paid only via a bank or postal account in the name of the student beneficiary.

ART. 5 - OBLIGATIONS

On their arrival, the students who have been allocated the contribution must sign the contract with the Conservatory of Cosenza; this contract will state the reciprocal obligations, the period of the mobility and the sum total of the scholarship.

The student who has been allocated the scholarship agrees to provide the Institute materials suitable for disseminating the results and promoting the mobility for study purposes. This documentation is: a detailed report of the activities and/or photographic, video or printed documentation regarding concerts etc.) and any other materials that illustrate the activities in which the student took part in





Cosenza. These materials will be used for the final report – as provided for in the contract between the Institute and the National Agency – and also to make this programme known, as an example, on the social media (the Institute's Internet site, the Conservatory's Erasmus Facebook etc.) as well as other informative events aimed at promoting the Erasmus+ activities organized by the Institute.

ART. 6 PRIVACY

The "Stanislao Giacomantonio" music conservatory is the "Holder of the Data Processing" and notifies, according to the provision of Art. 13 of the Legislative Decree of 30th June 2003, n. 196, that the student's personal data are processed by the Conservatory's staff both manually and using IT.

All relative data can be kept by the "Stanislao Giacmantonio" Music Conservatory and be relayed to universities, research institutes, the public administration and other organizations exclusively for institutional reasons and subject to the consent of the persons concerned.

ART. 7 THE PERSON IN CHARGE (LAW 241/1990)

ABSTRACT

Recipients: Students registered for a year following the first year in the Bachelor (ISCED 6) courses or in a Master (ISCED 7) course in the ERASMUS+ at a European Institution and who have signed a bilateral mobility agreement with the Cosenza Conservatory.

Requisites: Six months study at the Cosenza Conservatory (180 days)

Sum: 500,00€ per month paid by the fifth day of the month. Maximum sum: 3.000,00€ per student

Deadline 31st May 2017

Start of course: 1st September 2017
